The Saga of George Henry Stephens and the Early Days of the American Hotel

The American Block, now known as the Auburn Alehouse, is one of Old Town Auburn's most iconic buildings. For many years it was the Shanghai Restaurant & Bar and prior to that the Placer Hardware Store. In its early years, it was the American Hotel. Little has been written about the hotel's early years or the 49er (but not a miner) that had it built in the winter of 1855-56. His name was George Henry Stephens and this is an outline of his life in Auburn and the early days of the American Hotel.

Shortly after beginning this investigation it became apparent that one of Stephens' most notable characteristics was his remarkable talent for incurring debt. At his Insolvency Hearing in 1856 it was revealed that his total debts were \$28,763. By the most modest measure of worth, the relative value in today's dollars would be \$829,000. By other measures, it would be in the millions.

Therefore, it came as no small surprise to learn that George Henry Stephens, the owner/builder of the American Hotel, ended this life much as he had lived it - indebted to his friends. His pattern of indebtedness is unparalleled in the early history of Auburn. With over fifty court cases filed against him for nonpayment of debts, deeds, mortgages or bills it was remarkable that people continued to both lend him money or do business with him, but they did.

Less than a week after the opening ball for the American Hotel the local courts were swamped with an avalanche of complaints and filings for mechanic's liens against Stephens. (A mechanic's lien is a security interest in the title to property for the benefit of those who have supplied labor or materials that improve the property. - Wikipedia) Facing accumulated debts of \$28,763, Stephens filed for insolvency and the American Hotel was sold at public auction on October 23, 1856. This was the first of three times that Stephens lost the American Hotel to public auction. He was able to regain ownership after the first two losses (along with new debts), but not the third time on Oct 25, 1875. More details regarding these transactions, and other events in his life, follow.

Much of the available information about Stephens comes from an abundance of Placer County court and deed documents. Census records inform us that he was born in Connecticut about 1820. Although a birth record has not been found, we do know that his aunt, Anna (Tibbals) Karnes was born in Durham, Middlesex County, Connecticut. Stephens provided testimony that he traveled to California with a woman named Susan Smith and that they arrived at San Francisco on the 17th of October 1849. They had previously been resident in Louisiana. For the next six years Susan, Virginia born and seventeen years his senior, faithfully "superintended" Stephens' several businesses in San Francisco, Sacramento and Auburn. For all her work she received no wages and yet on the 20th of February in1856 she sold to Stephens the lot of ground on which the American Hotel was being built for \$1. This was a property she had purchased in 1852 for \$2200. One has to wonder at their relationship. She may have been first among many friends and acquaintances that Stephens took advantage of in Auburn.

A substantial remnant of Stephens' 1855 vision of the "most handsome building in the place" remains, a monument to his dream and to the skilled craftsmen of the day. At least a portion of the American Hotel has withstood the ravages of flood and multiple fires over the last 160 years. For the portions lost, the surviving newspaper and court records provide a complete inventory and description of the original hotel. In addition, a list of many known individuals involved in the construction of the American Hotel has been included in the end notes. It is seldom that this type of information is available actual builders usually remain anonymous.

This chronology begins with an obituary for George H. Stephens. Exactly thirty years had passed since his first arrival in Auburn and what a difference that thirty years had made. Over time, the once enthusiastic and energetic "wheeler-dealer" who'd been quick to take advantage of real estate and business opportunities in early Auburn had faded to a mere shadow of his former self. His wealth depleted once again, Stephens had lost the tenacity and resiliency that had once marked his response to adversity, whether it be fire, flood or debt and he quietly faded away in a upstairs room of the monument he had constructed for himself.

Death of George H. Stephens

George H. Stephens was found dead in his room at the American Hotel last Tuesday morning. He was lying on the bed in a natural and composed position. He had taken his boots off, but otherwise was fully dressed. On a table near the bed was a small box labeled "morphine," which plainly told the cause of death. The Coroner's jury, after inquiring into the case, concluded that death was caused from an over-dose of morphine, but did not indicate whether they believed it was administered with suicidal intent or not. On this there is a difference of opinion. He left no note or word of farewell, so far as has been found. Mr. Stephens was a pioneer and was one of the first settlers of the town Auburn. In early days he was well to do, and was characterized as an energetic and public-spirited man. He built the American Hotel in this town in 1855, and he built and equipped the original Empire Livery Stable. Adversity, however, long ago overtook him, and

for years he has been, as miners say, on the "bed rock." Reduced to poverty, he left this town some four or five years ago and has traveled around visiting different parts of the State and several of the Territories in hopes of regaining at least a portion of his scattered fortune. He returned, how ever, about five weeks ago as poor as when he left. He went about in a melancholy mood, and it would not be a matter of perfect surprise if he should have come to the conclusion that life for him was not worth living for. He was a native of Connecticut and at the time of his death about 62 years of age. A subscription was taken among his friends in town, and enough was raised to give him a decent burial. He was interred in Odd Fellows' Cemetery on Wednesday at 10 o'clock A. M.

George Stephens' quiet departure from life stands in marked contrast to his arrival and first few years in California where he, and Susan Smith, pursued business opportunities with apparent boundless energy. The following is a portion of the testimony included in the files for District Court Case 467, George Stephens vs His Creditors, it provides a brief history of Stephens's early days in California. It is dated Sept 1st 1856. The Plaintiff (Pltf) being referred to was Susan Smith.

Alfred Mason sworn - has known Plaintiff since 49. She was then in a coffee stand in a House kept by Stephens, this was in the fall of 49, as late as November, before the rainy season set in. They came (Deft & Pltf) to Sac City in the spring of 1850, this was just after the high water, they were keeping the "National House", they kept boarders remained there from 3 to 5 months keeping that house, say til May or June, they then went up on the Auburn Road between the Arkade and Oak Grove House. It was a public house. They then went from there to San Francisco - at San Francisco he kept the "California Exchange" this was in 1851, - they were not there long - came back to Sacramento, - moved around some and came to Auburn - saw him in Auburn in 1852 - they kept a Bar & had a few boarders, - they have been in Auburn ever since, kept a public saloon, up to 4th June it was the "Diane Bowling Saloon", in 1850, a woman's help was worth in Cal 300\$ per month, - in 1849 wages were about the same. In 1851 wages were about \$200 per month. In 1852 was worth about the same, in 1853 & 1854 they were worth 100\$ per month - the first five or six months of 1855, wages for women half been about \$75 per month, - Pltf was industrious and devoted to the interest of Mr. Stephens.

Pltf worked for Deft from 3 to 5 months in 1850, - in spring of 52 Pltf had charge of the house in Auburn, always seen her in that situation up to the fire in June 1855,

[(Questions by Myres attn for Medley & Co) Pltf objects to his appearing in the examination - objections overruled - ruling excepted to.]

S. C. Huntress - sworn, has known Pltf since 10th Decd' 1849. She was then in San Francisco. She was then keeping a coffee stand in Gore & Stephens house, it was a public house. He kept the house up to 1st Feby 1850, they were together - saw her next 22 March /55 She was then with Deft. He was then keeping the Diana Saloon. She was then working for him & staid there until the 4th June 1855. She has been living with him since then, keeping a private house until the opening of the American Hotel by Stephens. She is industrious and attentive to business has been so since have known her - her services are of as great value as any other woman.

Geo H Stephens sworn - voir dire - has no interest in the result of this suit. came to Cal with Pltf in Oct 49 - arrived 17 Oct 49. I then in a few days commenced a house on 6th of Nov 1849 Pltf first engaged in my employ. She attended for me a coffee stand and superintended a public house and ----- She continued in my employ then 5 or 6 months - thinks 5 months ____ She has been in my employ ever since 6th Nov 1849 except about 2 months, those 2 months were in 1852. _ Her labor services in 49 at least \$300 per month, in 1850 superintend a public house in Sac City labor was worth as much as in 49. In 1851 she was superintending public house on the Auburn Road. Her service were then 200 per month - In 1852 superintended public house in Auburn, her labor was worth about as much as in 1851. 1852 to present time her services have been worth 100\$ per month. ____ Her services were worth the amounts specified besides her board and all the clothing she got from me. ____ never made any contract for wages. Had she called on me for the amount of wages as I have specified, I should have felt bound to pay the money or give note, never regarding her as a partner. She owes me but a trifle _____ 1,000\$ would be a liberal allowance for clothing since she has been with me. X (by Myres) She worked for me because I requested her.

Susan Smith sworn for Deft Henson. Is Pltf in this suit. _____ commenced work in Nov 49 has been at work for him all that time except 2 or 3 months, _____ there were three partners in the house in 49. They each paid me 100\$ per month. Stephens did not pay his share, in 1850 the wage I think was worth 200\$ per month. In 1851, they were worth 150\$ per month, in 1852 my wages were worth 100 per month, in 53 was worth 150\$ per month, in 54 they were worth 100\$ per month, in 1855 the same. Worked for him all this time, the years I have mentioned. X I never received any of the money in San Francisco. Stephens charged them 300\$ per month for my services. _____ I looked to Stephens for my pay. I did not employ with the other partners.

Deeds, Court Cases, Liens & Misc.

Prior the lawsuit mentioned above, the following is an account of George's first business efforts and first real estate purchases after he and Susan came to Auburn.

AUBURN IN ASHES Loss over \$200,000 **EIGHTY HOUSES CONSUMED !!!**

"On Monday last about two o'clock P. M. a fire broke out in one of the Chinahouses on the side of the hill below the Methodist Church, which spread with fearful rapidity. The fire soon crossed the street to Dr. Kinzies Drug Store, thence to the Diana Bowling Saloon, Keehner's Bakery, Geo. H. Stephens' Livery Stable; the Empire and Orleans hotels soon followed in quick succession... The fire seemed fairly to lick up the buildings as it went," In the list of losses: George H. Stephens \$10,000. (This appears to include a house on Sacramento Street, Coffee Saloon, Empire Livery Stable, Bowling Saloon and Hog lot.)

(The future American Hotel.)

Even though George suffered huge property losses in the "big fire," his use of promissory notes and mortgages enabled him to acquire the financial resources to pursue his plans for the town. His brickyard was instrumental in the rebuilding of the town and he continued buying property. On the anniversary of the fire, the Herald noted (May 31, 1856) that Auburn had long been celebrated for its hotels—and that "they are better now than ever and that the 'American' is the most luxurious furnished house in

the mountains." In addition to the "The American" fourteen brick and stone houses were built (and an additional 130 frame buildings) after the fire.

"Stephens' new fire-proof brick hotel, the American, is a credit to our town, and perhaps the most magnificent establishment in the mountains. The brick portion is 112 feet in depth by 38 in width. The first floor contains the bar and dining rooms, the second floor two beautiful parlors and sixteen rooms. The third story is devoted entirely to bed rooms. In the rear of the brick is a frame addition, to be used as a kitchen and wood house below and sleeping apartments above. We understand it is to be opened for the reception of guests in a day or two, by a competent landlord, and that the Cal. Stage Company will stop there. There is to be a grand ball given at the American on the 7th, and we can promise the pleasure-loving public that no pains will be spared to make the entertainment worthy of the magnificent hotel."

At the time there were only seven hotels in town, the two previous largest, the Empire and National had been destroyed in the fire. The Traveller's Rest (now Bernhard Museum) and it's neighbor, the Crescent City, were far enough removed to escape without damage. The following complete the 1856 list of hotels that survived the fire: the Mansion House, Hotel de l'Union, the Orleans Hotel and the Gem. In quality "The American" was without local comparison.

The hotel was barely finished when the creditors started demanding payment. This pattern of incurring debt based on the good will of his neighbors and business associates was a hallmark of George's business dealings in town. There was little work done on the hotel that was fully paid for at the time of construction. Beginning below is the lengthy listing of court cases, mechanics liens and attachments brought against Stephens.

The large dining room of the establishment was used for dancing, and as the rich notes of the fine cotillion band in attendance, swelled through the spacious room, in mellifluous notes, the merry dancers became intoxicated with pleasure. All night long the twinkling feet kept tune with the violin and horn. Every luxury that could be obtained was served up at the supper table. The furnishing of this house surpasses anything we have seen in the mines, and in fact is equalled by very few hotels in our large cities. Excellent beds all over the house, all the rooms are carpeted and furnished wth other fixtures to correspond. In the parlor are the most luxurious chairs, stools, lounges, sofas, etc., etc., besides a pianoforte with music at hand. In the bar room there is a large safe, big enough to hold all the money in several such towns as Auburn. Mr. Stephens has spared neither pains or expense in the erection and furnishing of the American, and we hope the public will see him properly recompensed for his enterprise."

There is no known accounting of Stephens's expenses, but the lawsuits and mechanics liens continued unabated. Many people were carrying large portions of the hotel's cost. Some workmen had not been paid for months.

In spite of his losses, and ongoing lawsuits, George managed to regain ownership of the hotel. In the course of fifteen years A. P. Craner would come to his financial rescue many times. As a merchant himself, Craner had to have been aware of the risks involved in doing business with George. Perhaps the American Hotel was collateral enough to ease his concerns.

Adolph P. Craner, a Prussian by birth, arrived in California in 1848 and, with the exception of a few years spent in Auburn around 1860, lived most of his life in San Francisco. He became a naturalized citizen there in 1856 and married a few years later. From various newspaper accounts he appears to have been a very successful business man. He died in San Francisco in 1900, aged 75.

George's management style was to relegate responsibilities. Susan Smith "superintended" his various enterprises from 1849 to 1855. John Echols took over the American Hotel in 1856, months before it was surrendered to the court. And now we see that George Gazley has taken over in 1858. Further changes were to follow. We have used the Assessor Rolls to enumerate the owners of record between the hotel's opening in 1856 and Stephens removal by the sheriff in 1876. It is likely that Stephens was Morris's silent partner between 1864 and 1870. There are several clues that this was the case. Notice the drop in assessed value between 1864 and 1870 and then its jump back to pre-Morris values in 1872. It's as if there should have been another tax payer during the Morris years. Second, the Morris will leaves only his 1/2 interest to Stephens and finally, several mortgages in 1870 include the names of both Morris and Stephens.

With Samuel Morris on his death bed, George was up to his old ways again, buying and selling properties and incurring more debt. It may be on this date that George's final financial downward spiral began, a spiral from which he was unable to extricate himself.

Deceased was born in the city of Columbia, South Carolina, in 1814. When a young man he became an employe on a steamboat, and continued in various capacities, as chef Steward, part owner, etc., in that line of business, chiefly on the Mississippi and its tributaries, until the Spring of 1852, when he crossed the plains to California, and came to Ophir, in this county in the winter of 1852. After the great fire at Ophir in July, 1853, he built and opened the Mount Pleasant House, between here and Ophir. Afterwards, in 1855, he settled at Rattlesnake Bar, and remained there in business, keeping hotel, principally, until 1861 or '62, when he came to Auburn, and in April, 1864, become proprietor of the American Hotel, in which position he remained to the time of his death. S. G. Morris was a man of sterling integrity, energetic, persevering and honest in all his business relations, a high-toned, honorable, social gentleman, and one universally loved, respected and esteemed by all his acquaintances, and their name was legion. He had been unwell for weeks, when typhoid fever set in and proved fatal.

LARGE FUNERAL.-The funeral of S. G. Morris which took place from the American on last Monday, was one of the largest and most solemn ever witnessed in Auburn and showed clearly the profound respect with which the deceased was ever regarded by all classes of our citizens. The remains were buried in Odd Fellow's Cemetery, of which order deceased was an honored member. The Odd Fellows of Auburn with numbers from neighboring lodges, turned out in regalia, in a body and followed the remains to their last resting place. Funeral services were held in the parlors of the Hall, by Rev. J. H. Peters, after which the solemn procession formed, headed by the Auburn Brass Band, followed y the pall bearers bearing the silver mounted coffin profusely and handsomely decorated with wreaths of flowers; these by the Odd Fellows in full regalia, and these by ladies, then gentlemen and friends generally, all making a long, solemn and imposing procession. The band played solemn funeral dirges as the march continued to the cemetery, and during the services of interment and on the return of the brotherhood to their hall. Deceased, we think, had no enemy in the world, but the universal good will of all who knew him. Elsewhere, in its appropriate place, we have briefly noted an obituary.

George H. Stephens married Jane E. Bayley in Grass Valley, the daughter of A. J. and Elizabeth Bayley of Pilot Hill.

Little is known about George's private life, but the Bayley family of Pilot Hill were very wealthy. There were no notices of the marriage other than a one line announcement in the Placer Herald. It is surprising since both would have been notable figures in their communities. After the marriage they lived in Lotus. When A. J. Bayley died they moved into his house for a time (R. Lee). By 1880 Jane had a different husband.

Ann (Tibbals) Karnes was born 2 May 1806 in Durham Twp, Middlesex Co., CT. She married 26 Oct 1841 William F. Karnes in Adams Co., Illinois.

Ann died died 22 Oct 1873 in Chicago, Illinois. Her husband, William F. Karnes (1806 - 21 Aug 1849) died in Quincy, Adams Co., Ill. Ann was his second wife and together they had a son. George. Ann had a sister, Olive.

Olive (Tibbals) Goodwyn was born 30 Nov 1804 in Durham Twp, Middlesex Co., Connecticut. She married 12 Apr 1832 Thomas W. Goodwyn in Essex Co., New Jersey. He spent five years in California, from 1850 to about 1855. He returned to the family in Quincy, Adams Co., Illinois in 1855 where he remained the next ten years before returning to California. Thomas W. Goodwyn (26 May 1803 - 3 Oct 1888) appears to have left his family in Grass Valley and moved to Healdsburg, California where he died years later. Olive was resident in Grass Valley until her death 9 Aug 1884. The only indication that there was any contact between George Stephens and these relatives is that Olive's son Thomas Goodwyn was listed as living in Auburn (for just the one year) in the Great Registry of 1868.

This chronology began with one obituary and ends with another. A seeming failure for all his grand plans and despite some success, George returned to Auburn and the hotel he built and struggled so long to manage. His death in the American Hotel was a sad ending to an intriguing life. The local cemetery records no headstone for George, nor even his burial. Therefore it seems fitting that George's life is memorialized by his greatest accomplishment - the American Hotel building.

"George Stephens, and old-time resident of Auburn, was found dead in his bed at the American Hotel Tuesday morning last. Deceased had not resided in Auburn for three or four years past, but he returned here some three weeks ago from San Francisco and Grass Valley. He had evidently become discouraged with his situation and prospects in life, having, as he told friends here, tried every possible way to secure employment, but in vain; and he added despondently that he supposed he had outlived his usefulness. A few days after arriving here he indulged in one or two prolonged sprees, and had to be taken

in charge by the Sheriff. His death resulted from the overdose of morphine, taken very probably with suicidal intent. He was a native of Connecticut, aged 63 years, but he had lived many years in New Orleans before coming to California.
